Dr Amreek Singh Arora said that no splinter group should be formed and in all the previous meetings ministers and bureaucrats have negative approach and sometimes humiliate the IMA representatives. The ayushman empanelled hospitals carried out the meeting on 13th March despite IMA's no to the meeting. The reason for postponing the meeting was that the government is still not formed and portfolios not announced and we are not clear whom to meet. He further asked Dr Vig to detail about the 13th March meeting of the ayushman hospitals.

Dr Vig strongly refuted that a splinter group or association is made. He said that as the stakes are high and state IMA gave no decision or directions, 144 hospitals held a meeting on 13th March. There were no directions issued by the state IMA for not holding the meeting. He informed the house that some senior functionary of IMA told SHA that this scheme is being misused used by the doctors. For unknown reasons the government of Punjab withdrew the scheme on 29th December 2021 but verbally asked them to continue working for this scheme till 20th March and assured the release of payment but only a miniscule amount of payment was released till date. He said that IMA should issue directions to the hospital to stop working for the scheme. He further said that ayushman scheme holders are not in favor of a separate association and that IMA helped them a lot in the past and expect the same kind of help in future also.

Dr Devyanshu endorsed Dr Vig's comment and said he has not said anything against IMA president and it is only after reading the entire rules and details they are able to fight with the SHA.

Dr Yogeshwar Sud said no separate committee is formed and the proceedings of meeting should be put on WhatsApp groups.

Dr. Dheeraj Aggarwal 98154-00432 Dr Sarabjeet Singh suggested the committee to work under the umbrella of IMA and requested state IMA to issue an advisory/directive to the ayushman holders for working or not working for the scheme.

Dr Rajinder Sharma expressed his anguish over the WhatsApp comment by one of the ayushman scheme holder stating IMA leadership as fools and this post was not countered by anyone from ayushman scheme holders. The coordination committee found by IMA was rejected by ayushman stake holders. The 20th March meeting was postponed to 26th March because still no portfolios of the government are clear he asked the ayushman empanelled hospitals to support and believe in IMA. He further said that IMA cannot ask for a general strike or ask the ayushman holders to stop work.

Dr Sanjeev Mittal asked IMA to help and support ayushman empanelled hospitals and guide them.

Dr R. S Parmar suggested IMA to resolve any grievance by any section of IMA. For Corruption in the SHA, government officials should be held accountable, form a strong committee to resolve the issue and ask the SHA to give a clear and final date for the release of payment and urged ayushman hospitals not to bribe any ayushman official.

Dr Ashish Ohri said they asked many times for holding a meeting in the IMA house but it was not sanctioned and senior functionary of the state IMA were informed about the 13th March meeting.

Dr JS Sandhu said the authorities try to weaken the associations by saying anything and we should not fall prey to their tactics.

Dr Karamvir Goyal said the government should not get a hint of dividedness and any call or decision of the IMA should be implemented by a 100%.
